Specifically, if you are on 24-hour decision, you still need to place a protective block. If you are on IB, you still need to place a protective block. Regardless of the type of booking you are on (IB or 24-hour), if you got two back-to-back bookings with no gap, you would need to either move the dates (if on either IB or 24-hour), Cancel (if on IB) or Decline (if on 24-hour).

They may not know, but they can impose a wait period on your calendar of 24 hours between guests for all future bookings. It's likely that current bookings will remain the same, but all future bookings will have that imposed if the host certifies the cleaning protocol.
