SOLICITING | 3 Definitions of Soliciting - YourDictionary

A telephone buy (T-buy) is a form of Request for Quotation (RFQ), where bids are solicited from one or more selected suppliers verbally, in-person or over the telephone, for requirements below \$25,000 for goods and \$40,000 for construction and services, including all applicable taxes. Prior to soliciting a telephone bid, the contracting officer must verify the Ineligibility and Suspension List and ascertain that the bidder is not ineligible.

SACC Manual clause A9130T must be included in solicitations when there is production of or access to controlled goods. When the solicitation contains controlled goods (for example, a drawing or Statement of Work), only those controlled goods cannot be released to any persons that are not registered, exempt or excluded under the CGP. The remainders of the items are processed as usual.
